



# CONSERVATORY PLACEMENT ACTIVITY GUIDELINES

## INSTRUMENTAL MUSIC CONSERVATORY STRINGS & ORCHESTRA PROGRAM (Grades 7-12) Digital Submission Placement Activity

### Application & YouTube Video Submission

All applicants should submit a completed application and YouTube video, performing the materials outlined below. All repertoire and scales must be performed in a single take and time stamped. Total video length should be approximately 5-8 minutes.

### Video Content Guidelines:

All instrumentalists should film themselves performing the following:

#### 1. Scales:

- **Violin:** A major and c melodic minor (at least two octaves for 7th-8th grade applicants and three octaves for 9th-12th grade applicants)
- **Viola:** D major and f melodic minor (at least two octaves for 7th-8th grade applicants and three octaves for 9th-12th grade applicants)
- **Cello:** D major and f melodic minor (at least two octaves for 7th-8th grade applicants and three octaves for 9th-12th grade applicants)
- **Bass:** F major and a melodic minor (two octaves)

**Note:** All scales should be performed slurring four sixteenth notes with quarter beat = 60 to 100 bpm.

2. One slow movement from a Bach suite/sonata/partita **or** similar piece. Approximately 2-3 minutes.
3. One fast movement from a standard concerto **or** similar piece. Approximately 2-3 minutes.

**Note:** 7th and 8th graders are required to perform repertoire from **at least** Suzuki Book 4 or higher; 9th-12th graders are required to perform repertoire from **at least** Suzuki Book 6 or higher (or comparable repertoire).

**Harpists:** Must demonstrate facility with the seven-pedal harp. Please perform one slow, lyrical, melodic piece and one fast, technical piece.

*\*We highly recommend you select standard string repertoire and exclude popular music, arrangements of classical repertoire, and concerti.*

## **Video Submission Guidelines:**

- To protect your privacy, your YouTube video should be saved as “UNLISTED” so it cannot be publicly viewed.
- Copy and paste your YouTube video URL (web address) directly into your conservatory application.
- YouTube video must be included at the same time as the application submission.
- At the beginning of your video, please start by clearly stating your name and the grade you are applying to. Be sure to indicate if you are a current OCSA student, and, if so, which conservatory you are in.
- Please state the date before you perform the items. (i.e. “Today is December 1, 2025.”)
- The YouTube video should have no disruptive background noise, good lighting, and a framing that views the student’s hands and torso in the video.
- The video should be filmed in landscape orientation (horizontal). Do not film in mirror mode.
- It is not required that the format be a professional or studio recording, but the sound quality should be as good as possible. **All recordings must be unedited.**
- Once your YouTube video has been submitted to OCSA, the submission is final and changes cannot be made.
- YouTube video should be specifically produced for your OCSA application. Do not include videos from previous stage performances.
