



# CONSERVATORY PLACEMENT ACTIVITY GUIDELINES

## INSTRUMENTAL MUSIC CONSERVATORY PIANIST PROGRAM (Grades 7-12) Digital Submission Placement Activity

### Application & YouTube Video Submission:

All applicants should submit a completed application and YouTube video of the following: three (3) solo works based upon the guidelines below, plus two (2) scales of your choice. All repertoire and scales must be performed in a single take and time stamped.

### Video Content Guidelines:

1. Select one (1) composition by J. S. Bach from the following list:
  - Sinfonia, BWV 787-801
  - Prelude AND Fugue from Books I or II of *The Well-Tempered Clavier*
  - Toccata, BWV 910-916
  - Any two movements/variations from the French, English Suites, Partitas, or Goldberg Variations
  - Any Italian Concerto movement
2. First movement of a standard Classical Sonata by Haydn, Mozart, Beethoven, or Schubert. Please exclude Haydn Sonatas, Hoboken 1-30, Mozart Sonata K 545, and Beethoven Sonatas op. 49.
3. One major work or movement by a Romantic era or 20<sup>th</sup> / 21<sup>st</sup> century composer.

*\*We highly recommend you select standard piano repertoire and exclude popular music, arrangements of classical repertoire, and Concerti.*

*\*All pieces must be played from memory.*

Grades 7 & 8: Play two (2) scales of your choice drawn from any of the 7 major scales beginning on white notes, 4 octaves played hands together in sixteenth notes at MM=110.

Grades 9-12: Play two (2) scales of your choice drawn from any major or minor scale, 4 octaves played hands together in sixteenth notes at MM=120.

### Video Submission Guidelines:

- To protect your privacy, your YouTube video should be saved as “UNLISTED” so it cannot be publicly viewed.



# CONSERVATORY PLACEMENT ACTIVITY GUIDELINES

- Video should be made specifically for OCSA Pianist Program Placement Activity and recorded in a single session, with all repertoire and scales played back to back, much like in a live performance. No past Placement Activity repertoire can be used. Please timestamp your video before you submit.
- Copy and paste your YouTube video URL (web address) directly into the appropriate field in your conservatory application.
- YouTube video must be included at the same time as the application submission.
- At the beginning of your video, please start by clearly stating your name and the grade you are applying to. Be sure to indicate if you are a current OCSA student, and, if so, which conservatory you are in.
- Please state the date before you perform your repertoire. (i.e. "Today is December 1, 2025.")
- The YouTube video should have no disruptive background noise, good lighting, and a framing that views the student's hands and torso in the video.
- The video should be filmed in landscape orientation (horizontal). Do not film in mirror mode.
- It is not required that the format be a professional or studio recording, but the sound quality should be as good as possible. All recordings must be unedited.
- Once your YouTube video has been submitted to OCSA, the submission is final and changes cannot be made.
- YouTube video should be specifically produced for your OCSA application. Do not include videos from previous stage performances.
