CLASSICAL VOICE CONSERVATORY (Grades 7-12) In-Person Placement Activity

Placement Activity:

After your online application is processed, you will be invited to participate in an in-person placement activity.

Please **prepare two (2) classical songs or arias**. Classical musical theater will also be accepted. Selections may be sung in English or in the original foreign language. Applicants will also be asked to perform a **short sight-reading and ear-training example** to demonstrate readiness to participate in musicianship and music theory classes.

Below is a list of song books which contain commonly used classical repertoire. Placement activity material is not limited to the following examples, but should be appropriate to the student's vocal range and ability:

- 24 Italian Art Songs by G. Schirmer / Hal Leonard
- 24 Italian Songs and Arias by Women Composers – Hildegard Publishing Company
- 15 Easy Folksong Arrangements by G. Schirmer / Hal Leonard
- The First Book of (Soprano, Mezzo-Soprano, Tenor, Baritone) Solos by G. Schirmer / Hal Leonard
- Musical Theatre Anthologies (the non-belter edition) by Hal Leonard
- Songs by the following composers and their contemporaries (representative list only):

Additional guidelines:

- An accompanist will be provided or you can bring your own accompanist. Please bring clean sheet music prepared three-hole punched and double sided in a binder for the accompanist (no staples or clear sheet protectors, please).
- Please have songs memorized.
- Applicants will be asked to select a voice part (Soprano/Alto or Tenor/Bass) when completing their application. Please select the vocal range that best represents your comfortable singing range, as **faculty will evaluate you based on the vocal part you choose during the placement activity.**
 - **Soprano/Alto:** Higher vocal ranges that typically carry upper melodies or harmonies in an ensemble.
 - **Tenor/Bass:** For applicants who have not gone through a voice change yet, but will eventually be a tenor or a bass, please select this concentration.
- It is recommended that applicants attend their scheduled appointment dressed professionally.
